REVOLUTIONARY HISTORY—250 YEARS



The Battle of Fort San Carlos

The Battle of Fort San Carlos, sometime called the Battle of St. Louis, was fought on May 26, 1780, between British allied Indians and defenders of the Franco-Spanish village of St. Louis, Louisiana (present day Missouri).

After Spain entered on the side of the Americans, the British attempted to control the Mississippi River corridor against Spanish and Patriot military movements.

St. Louis was mainly a trading hub on the Mississippi River, and was governed by Lt. Gov. Fernando de Leyba, a Captain in the Spanish Army, but it was also the administrative capital of Upper Spanish Louisiana. Lebya was warned by a fur trader, in late

March 1780, of an impending British attack on the settlement and the nearby American post at Cahokia. He started to develop plans for defense, but he only had 168 inexperienced militia dispersed around the countryside, and only 29 men from the Fixed Force of Spanish Louisiana. He planned to construct 4 stone towers, but did not have the time to get men and material from New Orleans. He asked the surrounding villagers to contribute funds and labor to the construction of these fortifications, and he paid for some of it from his own personal funds.

By mid May, only one stone tower was constructed. The tower was dubbed Fort San Carlos and it gave a commanding view of the countryside. There was no time to build more towers, so Fort San Carlos was outfitted with 3 four pound cannons and 2 six pound cannons for its defense, with other cannons place at perimeter locations in trenches dug around the fort. The Spanish called upon French defenders, 60 miles to the south, to come to their aid, as the Spanish only had 197 men, and the French sent 60 more capable defenders to help tip the balance against the overwhelming British attack. The defenders took some losses but were able to hold the tower. The Indian force fell back and attacked the American Cahokia outpost, but were again repelled by the arrival of Gen. George Rogers Clark in defense of Cahokia. Clark's reputation as a brutal frontier fighter, caused the Sioux force to call off the attack.

On May 26, 2024, Nebraska 1st Vice President and Color Guard Commander, Paul Burrignt, traveled to Ste. Genevieve, MO to participate in the commemoration of the Battle of Fort San Carlos, and to participate in the National SAR Color Guard in marking the graves of 5 Revolutionary War Patriots who fought in the battle. He was joined by fellow Iowa SAR Compatriot Randy Lyon, to represent Nebraska and Iowa in the National Color Guard.

The five Patriots honored were: Charles Belmar, Jean Babtiste Fortin, Joseph Courtois, Israel Dodge, and Raimond Govreau. They were buried in unmarked graves, believed to be located in what is now Memorial Cemetery, created in 1787, in Ste. Genevieve, MO, exact burial places were unknown. Their names are now engraved on a Patriot Board to be housed in the Ste. Genevieve Museum. The Missouri SAR also dedicated a new highway marker, located just outside the cemetery, commemorating the lives of the Patriots buried in the cemetery and their service during the Revolution.



MEET MY PATRIOT



Daniel Shed/Shedd (P-288283)

Daniel Shed (Shedd and Sheds) was born at Groton, Massachusetts, April 15, 1746 or 1749. He served as a Private in Captain Asa Lawrence’s Company, Colonel William Prescott’s Regiment, enlisting on Apr 25, 1775.

Private Shed served three months and eight days (eight months by another account), during which he engaged in the Battle of Bunker Hill. Jul 9, 1777 found him marching in Captain Joseph Barrett’s Militia Company, Colonel Nichol’s Regiment of Militia into the Continental Army, joining Captain Isaac Frye’s Company in Colonel Alexander Scammell’s Third New Hampshire Regiment.

The 1790 United States Census lists him as residing in Shelburne, Vermont as the father of two males over the age of sixteen, three males under sixteen, and a female. As a resident of Dearborn County, Indiana, he filed a pension application on Oct 2, 1819, claiming enlistment from Raby, New Hampshire and engagement in the Battles of Bunker Hill and Bennington in Captain Fry’s [sic] Company, Colonel Baldwin’s (later Colonel Scammell’s Regiment).

His place of death and final resting place are unknown.

Compatriot Grave Marking

Honoring Gilbert L. Cole



The Nebraska SAR hosted its 6th Compatriot grave marking on Saturday, June 22, 2024, in Beatrice, NE. This ceremony was to honor founding Nebraska SAR Compatriot Gilbert L. Cole. Compatriot Cole's National Member number was #4611 and his Nebraska SAR member number was #11. He was one of the original 12 members approved when the Nebraska SAR was formed on April 26, 1890. He was a descendant of Revolutionary War veteran John Cole, who served in the New Hampshire Militia, and was engaged at the Battle of Bunker Hill, as well as being called in defense of Fort Ticonderoga. Compatriot Cole was himself a veteran, serving in Co. E, 29th Iowa Infantry, in 1861. He was also commissioned as a Lieutenant in Co. A, 124th U.S. Colored Infantry.

President John Braisted presided over the ceremonies, Lincoln Chapter VP David Ensign provided Chaplain duties, State Secretary Dale Wostrel led the audience in the Pledge of Allegiance and SAR Pledge and Recessional, and State Historian John Reinert led the audience in singing the National Anthem and gave a brief history of the Nebraska SAR. State Registrar Mark Byars read the biography of Gilbert Cole, and State 1st VP Paul Burright read the biography of Revolutionary War veteran John Cole.

A very good turnout was had for the service, and a special thanks to members of the Kansas SAR Color Guard who joined us to honor Compatriot Cole, as well as members of the Nebraska Rangers, Sons of Union Veterans of the Civil War, who attended to honor Lt. Cole's service for the Union with a musket salute.

Fourteen wreaths were presented by State Societies and Chapters of the Nebraska SAR, Nebraska DAR, Kansas SAR, North Central District SAR, Sons of Union Veterans of the Civil War, and Daughters of Union Veterans of the Civil War.

Nebraska Compatriots,

I want to begin this article by expressing my sincere appreciation for the work of our Officers and Committee Chairmen from the past term, as well as those members who have contributed countless hours over the years to enhance and help grow the Nebraska SAR into what it has become today. We are on a great trajectory as a Society, even though we are still a very small Society in comparison to nearly all our neighboring States, and we do not want to lose our momentum.

Ask yourself, "What can I offer the Nebraska SAR as a member?"

All of us have different strengths that we can offer in service. Are you good with computers and web building? Are you good with marketing? Do you enjoy teaching and speaking to a group? Outside of the participating Officers and Color Guard members, only a handful of Compatriots answered the call to honor this veteran and founding member and support this event, and we were outnumbered by members of the other lineage societies that we invited as guests.

When you also look at the attendance for the State Meetings (April and September), we typically have the same 15-20 members (out of 141 state members), which includes the Officers, who attend regularly. This same minority number of members cannot continue to do the majority of the Society's work. We try to keep everyone informed of upcoming events through this newsletter, but if you never attend any meetings (Chapter or State), how can you really know what is happening in your Society?

Get involved and contribute to the workings of your Society!

Gentlemen, we have numerous committees that need you on them, and some that need leaders!

Were you aware that we have 14 standing committees in the Nebraska SAR? Some of these are led by State Officers and some of them have appointed Chairmen, but they all need to be filled with workers, like you, that can contribute and continue the work of the Society in your communities. It is a great way for any of our 141 members to get involved!

One way that we can continue to attract new members is for them to see our current members doing work in the Society, and community at large, that they respect and value. When our new members get involved, we can do more of that work, but it starts with the example set by the current membership.

Remember that we also live in an age where we have technology to where we don't have to have our committees meet in person, per se. We have the capability to use Zoom (my own Constitution & By-laws committee has already met through Zoom as our committee members live in different cities). We can help you to set something up if you need help.

Compatriots, our society cannot move forward, and will grow stagnant, if we don't fill these open spaces. The next page shows all 14 committees and our needs on them. We currently only have 4 committees that are fully staffed and operating, three that are only partially staffed (with generally only a Chairman), and five committees that have no Chairman or staff at all. All of you have heard the saying "Many hands make light work". It is extremely true for these committees. None of these require a lot of time, but the work is important.

I want to thank all of you for being members of the Nebraska SAR!

I realize that some of you do not live in Nebraska, and that makes it nearly impossible to be as involved as you might want to be. I hope this newsletter, as well as our other communications and information items we produce, show you what your dues are going towards for our outreach in our communities.

I also realize that the SAR is not our sole thing in life and that we all have very busy lives outside of our membership in this Society, whether it is your job, your kids and their activities, or other organizations you are a part of. Nobody is asking you to be the next John Adams and work on 26 different committees, as he did in the Continental Congress, but my hope is that you will want to work on at least one of them and do your part to help.
